## What is the purpose of this update?

This document tells you how the Lifestages World Bond Portfolio has performed and what fees were charged. The document will help you to compare the fund with other funds. Funds Administration New Zealand Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

The fund aims to provide investors with a broadly diversified portfolio of international investment grade income securities. The fund offers a multi-manager approach to fixed interest investing.

## What are the risks of investing?

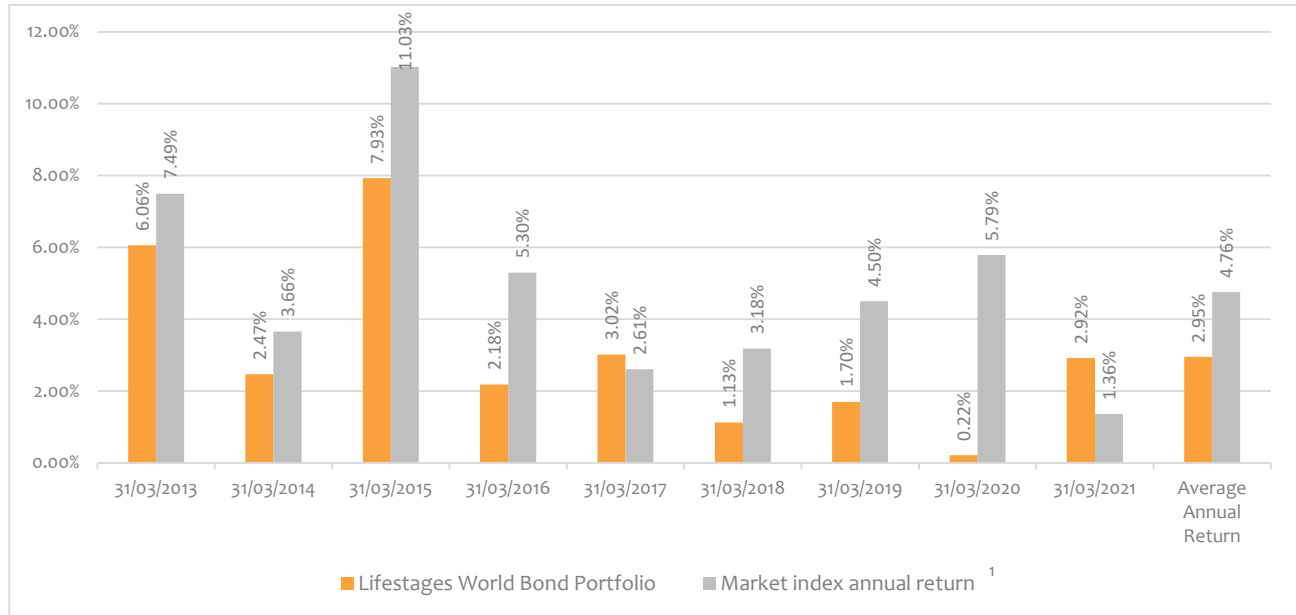
## How has the fund performed?

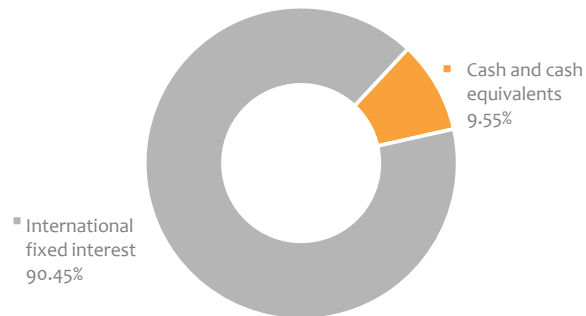
## Example of how this applies to an investor

Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley incurred a loss after fund charges were deducted of -\$189 (that is - 1.89% of her initial \$10,000). This gives Hayley a total loss after tax of -\$173.00 for the year.

### Currency hedging

As at 31 December 2021 the fund has an exposure to foreign currency assets of 90.45%, of which 90.45% was hedged back to NZD. This means the fund's foreign currency exposure is 0.00%. Our estimates are made on the basis of reasonable assumptions about the ongoing level of fees and costs expected to be charged (taking into account the actual fees and costs as a percentage of average net asset value that were charged for the most recent scheme year). These fees are deducted from, and reflected in the unit price of the fund.
