What is the purpose of this update?

This document tells you how the Lifestages Auto Option age 50 - 54 has performed and what fees were charged. The document will help you to compare the fund with other funds. SBS Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

This life cycle investment stage invests 80% in the SBS Wealth High Growth Fund and 20% in the SBS Wealth Income Fund, which is regarded as providing appropriate levels of risk and return for a person aged 50-54.

What are the risks of investing?

Risk indicator for the Lifestages Auto Option age 50 - 54:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



Example of how this applies to an investor


Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley received a return after fund charges were deducted of \$563 (that is 5.63% of her initial \$10,000). This gives Hayley a total return after tax of \$453.91 for the year.

Currency hedging

As at 31 March 2025 the investment option has an exposure to foreign currency assets of 79.35%, of which 41.17% was hedged back to NZD. This means the fund's foreign currency exposure is 38.18%. - ¹ Note that market indices reflect no deduction for charges and tax.
- ² This covers expenses incurred in running the fund (e.g. accounting, audit, and regulatory compliance costs). GST will be included in some expenses, where applicable.
