What is the purpose of this update?

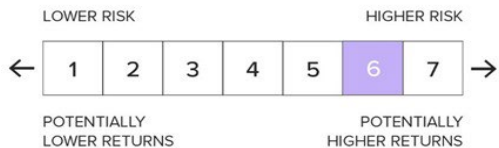
Description of this fund

The fund aims to provide investors with a higher risk investment option that achieves capital growth over the long term. The Fund invests in a concentrated selection of international equities, with a small amount in cash.

What are the risks of investing?¹

Risk indicator for the SBS Wealth Focused Growth Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

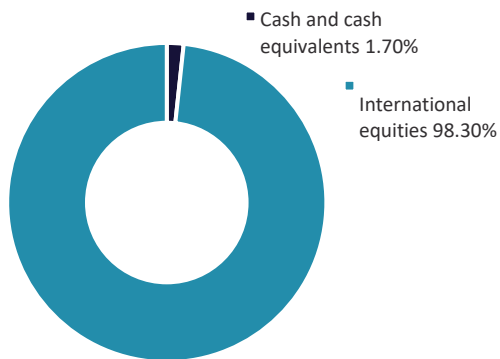
Example of how this applies to an investor⁴

Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley received a return of \$2,219 (that is 22.19% of her initial \$10,000). This gives Hayley a total return of \$2,219.15 for the year.

The top 10 investments make up 70.21% of the net asset value of the investment option.

Currency hedging

As at 30 September 2025 the investment option has an exposure to foreign currency assets of 98.69%, of which 55.31% was hedged back to NZD. This means the fund's foreign currency exposure is 43.38%. Notes

- ¹ As this Fund started on 28 April 2025, five-year actual returns for the Fund are not available. To calculate the risk indicator for the five-year period ending 30 September 2025, market index returns have been used up to 30 April 2025 with actual Fund returns used for the balance of the period. As a result of those market returns, the risk indicator may provide a less reliable indicator of the potential future volatility of the Fund.
- ² As this Fund started on 28 April 2025, annual fund charges of the investment option for the year to 31 March 2025 are not available. The charges reflect the fees disclosed in the PDS dated 28 April 2025 instead.
- ³ This covers expenses incurred in running the Fund (e.g. accounting, audit, and regulatory compliance costs). This also covers the Supervisor's annual fee (for the services it provides) and an estimate of fees and expenses incurred by the underlying funds. Our estimates are made on the basis of reasonable assumptions about the ongoing level of fees and costs expected to be charged (taking into account the actual fees and costs as a percentage of average net asset value that were charged for the most recent scheme year). These fees are deducted from, and reflected in the unit price of the fund.
- ⁴ As the Fund started on 28 April 2025, an annual return for the Fund for the year ended 30 September 2025 is not available. For the purposes of the investor example, the return is the actual return of the market index for the period 1 October 2024 to 30 September 2025 with no deductions for charges and tax.
